## POLICE EMERGENCY DECLARATION

Upon motion by Castle, seconded by Clere, council voted to declare an emergency for the police cruisers. This emergency becomes necessary due to July 11, 2021, multi police cruiser accident involving a chase with a violator that damaged (2) two cruisers. All present voting yes.

## PLANNING AND ZONING UPDATE

The council received an update regarding the training of the committee members. The top issue was determining how mobile and modular homes are affected by the current ordinances, and what restrictions are in place now and what changes a new ordinance should include if a citizen desires to put such homes on property they already own or would purchase in the city limits. The need for a Code Enforcement Officer was also addressed to the council.

## MAIN STREET

Upon motion by Castle, seconded by Taylor, council voted to grant \$20,000.00 to the Main Street Program. Mayor Day said the Boyd County Fiscal Court had agreed to match those funds to help with city renovations. It was decided to give the funds as a block grant rather than on a reimbursement basis. It was a line item in the new budget. All present voting yes.

Floodwall Supervisor has asked for a new mower costing $\$ 17,500$. It was reported that the seat on the present one is broken. Council agreed that he needs to check on getting the seat fixed.
